# 070/24 Meeting Minutes Tuesday 04 June 2024

#### 072/24 Network Rail

It was noted that a meeting is to be set up in the coming weeks to discuss Network Rail's plans for the land adjoining the railway line.

#### 073/24 Second Island Stone prices

It was **resolved** to replace the River walkway plaque with a bronze plaque at an indicative cost of £654.82 plus Vat and postage & further **resolved** to replace the broken Millenium plaque with a stainless steel plaque at an indicative cost of £226.67 plus Vat and postage. Prior to ordering the replacement River walkway plaque the clerk was instructed to contact the family to advise that the Council has considered the longevity of the proposed replacement plaque and that the Council's preference is to replace the slate plaque with bronze. Vote -6 in favour, 1 against.
