Works to trees in a Conservation Area for Maple (T1) – fell due to overshading, outgrowing of position and suppression of neighbouring Conifer. Oak (T2) – crown reduce North West side and reshape to address heavy lean. Sycamore (T3) – fell due to basal cavities and potential rot/disease (honey fungus), as well as possibly dangerous girdled stems. Oak (T5) – fell due to impacts caused to property by the roots/root plate. Western Red Cedar (T5) – fell due to rootplate movement. 6 x Leylandii (G1) – fell due to unbalanced form and possibility of falling,

trees may be dead on South West side.
Replanting of native species (such as beech or oak) and shrubs would be considered

352/24 Cornwall Council Local Plan Call for Sites

It was **resolved** to comment on the three sites submitted as follows:-Site ID 267442

The Town Council considers that this site is very divorced from the existing settlement and does not have the potential to come forward in the next three years. The risks/issues that may impede deliverability which the Town Council wishes to highlight are as follows:-

- Lostwithiel is prone to flooding badly due to both tidal & fluvial flooding. This site is not in the Flood Zone but surface water runoff would impact towards the bottom of Mill Hill, if this site goes forward for development the Town Council would wish to see tanking of the surface run off and a clause for regular maintenance of said tank. All too often development has been approved with a surface water tank and after the build is completed the tank receives no maintenance and blocks.
- The Town Council also wishes to emphasise that the town's infrastructure is already at capacity and given the distance to the settlement this site would exacerbate these limitations. Furthermore, it is the opinion of the Town Council that this particular site would have an adverse effect on the registered Battlefield and the aesthetics of Restormel Castle.

Site ID 267441

The Town Council does not consider this site has the potential to come forward in the next three years. The risks/issues that may impede deliverability which the Town Council wishes to highlight are as follows:-

- Lostwithiel is prone to flooding badly due to both tidal & fluvial flooding. This site is not in the Flood Zone but surface water runoff would impact towards the bottom of Mill Hill, if this site goes forward for development the Town Council would wish to see tanking of the surface run off and a clause for regular maintenance of said tank. All too often development has been approved with a surface water tank and after the build is completed the tank receives no maintenance and blocks.
- The Town Council also wishes to emphasise that the town's infrastructure is already at capacity and that if this site goes forward for development part of the site needs to be utilised to improve road access.

Site ID 269071

The Town Council does not consider this site has the potential to come forward in the next three years. Of the three sites currently put forward for consideration this site has the most potential as it is immediately adjacent to the existing settlement. However, the risks/issues that may impede deliverability which the Town Council wishes to highlight are as follows:-

- Lostwithiel is prone to flooding badly due to both tidal & fluvial flooding. This site is not in the Flood Zone but surface water runoff would impact towards the bottom of Mill Hill, if this site goes forward for development the Town Council would wish to see tanking of the surface run off and a clause for regular maintenance of said tank. All too often development has been approved with a surface water tank and after the build is completed the tank receives no maintenance and blocks.
- The Town Council also wishes to emphasise that the town's infrastructure is already at capacity and that if this site goes forward for development part of the site needs to be utilised to improve road access.
